TOWN OF BEAUSEJOUR BY-LAW NO. 1759-18

BEING A BY-LAW OF THE TOWN OF BEAUSEJOUR to establish indemnities to be paid to members of the Council

WHEREAS Section 124(2) of The Municipal Act, S.M. 1996, c. 58, provides:

Council may set compensation and expenses

- 124(2) A council may by by-law set the types, rates and conditions of payments to be made to or on behalf of members of the council and committees, other than the committees of a local urban district.
 - (a) as compensation for attending to municipal business;
 - (b) for expenses incurred while attending to municipal business; and
 - (c) for any other purpose relating to municipal business that the council considers appropriate.

NOW THEREFORE the Council of the Town of Beausejour enacts as follows:

- 1. That the Mayor be paid an indemnity in the amount of \$19,576.00 per year and be paid on an equalized payment of \$1,631.33 per month;
- 2. That the Deputy Mayor be paid an indemnity in the amount of \$16,200.00 per year and be paid on an equalized payment of \$1,433.17 per month.
- 3. That the Councillors be paid an indemnity in the amount of \$14,962.00 per year and be paid on an equalized payment of \$1,246.83 per month.
- That annual increments of Mayor and Council indemnities shall equal the cost of living allowance as defined in the employee union agreement;
- 5. That each member of council attending a regular meeting, special meeting, committee meeting, public hearing or any meeting organized by the Municipality outside of the Town of Beausejour, with the exception of the RM of Brokenhead Office, be paid as follows:
 - a. the sum of \$100.00 for meetings up to 4 hours in duration;
 - b. the sum of \$200.00 for meetings over 4 hours in duration.
- 6. That registration fees, membership fees or tuition fees payable for attending authorized conventions, conferences or seminars shall be paid by the Town of Beausejour on behalf of Town Council or Town Employees.
- 7. That mileage shall be paid at a rate of forty-five cents (\$0.45) per kilometre for each kilometre travelled, as authorized by Council.
- 8. That Mayor and Council may choose to participate in the Town of Beausejour Blue Cross Insurance Program; the program shall be covered 100% by the council member;
- 9. That out of pocket expenses for meals, as authorized by council shall be paid as follows:

a) Breakfast, maximum per day

\$ 20.00

b) Lunch, maximum per day

\$ 25.00

c) Supper, maximum per day

\$ 40.00 \$ 85.00

10. That By-Law No. 1725/15 be hereby repealed.
